

- COVID-19
- > The Key Requirements to be kept and even developed
  - Trust in Quality Performance
  - Confidence of Customer
  - Compliance to Standard
- Necessity to be Agile
- Without any compromise on the Quality of the audits





#### Remote audit

#### SOME POINTS OF ATTENTION

- Relevancy of the risk analysis versus reality
- >Accuracy and relevancy of KPIs
- Process reviews & management review outputs versus field reality
- ➤ Assessment of Key Processes & special processes & Manufacturing Processes
- Customer Perception





#### In a nutshell

#### REMOTE AUDITS, it is:

- > Preparation (documents), preparation (IT, camera) & preparation (test)
- > Defined & adequate process to ensure relevancy of the conclusion
- ➤ Sharing of Experiences to learn and improve from past experiences
- Discipline
- ➤ Strong control (e.g.: witness audit)

## What important aspects should be addressed during an IRIS remote audit?

The health situation has allowed us to develop the practice of remote audits
Remotes audits are not intended to replace face to face audits
The aim is to maintain the certification system operationnal in a constrained context
This transitional situation while allowing the maintenance of the IRIS certification in a given framework
These requires working with trust from all stakeholders and with vigilance regarding the level of requirement
Enhanced audit preparation between auditees and auditors is a main condition
It's important to rely on audit evidence provided by auditees with dynamic means is
It leads us to evolve by ensuring that they are properly implemented
The measurement of the performance of IRIS certified companies guarantees us responsiveness to any degradation
The available feedback shows a rise in competence of all the actors due to their efficiency
The current scoping must therefore remain reviewable to consider its continuity in a suistainable degraded context.



## What important aspects should be addressed during an IRIS remote audit?

#### Remote Audit prerequisites/Conditions



#### **Legal Requirements**

The organization and the certification bodies shall ensure that electronically exchanged datas are safe and that confidentiality requirements are met.

Confidentiality agreement for each auditor is granted.

The preparation of the audit is sizeable It needs anticipation around the 5 axis. The pedagogical face must be replaced by a GAME situation




## The "NEW normal" way of working





## Difficulties for remote auditing










## Which area do you think is the hardest to be assessed remotely?










## Prerequisites for remote auditing









#### Audit types eligible for remote auditing

- Readiness Review,
- Surveillance audit,
- Re-audit,
- Remote follow-up of CARs,
- Re-certification audit







### Audit types excluded from remote auditing



- Pre-audit,
- Certification audit,
- Transfer audit between Certification Bodies,
- Audit after changes impacting the management system with 10 points or more,
- Two (2) consecutive remote audits,
- Conflict resolution/ handling of critical issues/ complaints.

- Prerequisites for auditors
- Prerequisites for organizations
- Prerequisites for control
- Prerequisites for the audit
- Trial meeting

#### Audit Planning

Identification of technical equipment
Video conference with screen share
Access to the business management
system documentation

#### Audit Plan

Prepared by Lead Auditor and agreed by the company Audit
Plan reflected all required details



# REMOTE AUDITING AUDIT REALIZATION




#### Office session

Audit of processes which can be presented by sharing screen e.g.:

- Review of requirements
- Project management

# REMOTE AUDITING MAIN ISSUES





#### Main interruptions during remote audits

- Audit Participants are not familiar with communication platform used to conduct audit.
- Meeting settings screen.
  - Missing reliable internet connection in workshop areas.

#### Conclusion

Minimization of unexpected situations during preparation phase of remote audit increase level of effectiveness

## REMOTE AUDITING SUCCESS CONDITIONS





#### PREPAREDNESS AND ANTICIPATION

- Get prepared as usual on the audit expectations (process/perimeter/people)
- The use of ICT shall not be a stake : Site team need to be trained on the ICT usage
- An Audit coordinator will be extremely important to manage "audit logistics".
- All the attendees to be informed, trained and ready with ICT usage for answering
- In case of on-site process audit (shop floor) prefer to use tablet or smartphone.
- Test network connectivity performance. Back-ups are welcome (2nd Device, fully charged)






